In an Organizational meeting held on January 2, 2024, the Orange County Broadband Authority Board made the following appointments:

Election of Chairman of the Board – Tom Lachney, County Attorney opened the floor for nominations for Chairman of the Board. Keith Marshall made a motion to nominate R. Mark Johnson as Chairman of the Board. Bryan Nicol seconded the motion. The motion was unopposed and passed unanimously. Tom Lachney handed the floor back to the Chairman Mark Johnson.
